086/22 Planning Application:
22/0631/FUL - Bones Farm Mount Lane Kirkby La Thorpe - Erection of an agricultural grain store
- It was RESOLVED to respond to the application in the following manner.

Kirkby La Thorpe Parish Council are concerned about the increased volume of traffic that the extra grain store will place on Mount Lane, especially when the majority of this traffic will consist of large agricultural machinery and bulk transport vehicles.

Mount Lane is already suffering significantly from flooding due to blocked road drainage caused by mud dropped from agricultural vehicles and has been the focus of many complaints, discussions, reports, and escalations over a long period of time.

The Parish Council understands that this is an agricultural area but there needs to be a balance with the existing residents needs and the associated highways services.

If the applicant were to relinquish the historical planning granted many years ago for a storage building, the development of which has not been progressed, then the net effect would result in no extra planned loading on Mount Lane and the Parish Council would then have no objection.

However, if the existing permission is retained and developed, together with the granting of this extra application, then the Parish Council seriously object on the basis of highway impact, including lack of effective drainage, and the subsequent impact on the residents of Mount Lane.

We believe this to be both a Highways and an Environmental matter.
